#### **SECRETARY'S REPORT:**

We are pleased to present the Annual Report for the year 2022-2023 of The Sarat Chandra Kagti Charitable Trust, a beacon of hope and transformation in a landscape of deprivation and neglect. At the core of the Trust lies a profound commitment to uplifting the most vulnerable and marginalized sections of society who languish at the bottom of the pyramid.

Since our inception in 2017, our guiding philosophy has been to effectively channelize financial assistance and other resources to address pressing social issues at the grassroots level, which often remain overlooked by mainstream philanthropic organizations. Our journey began with a singular purpose – to make a meaningful difference in the lives of those who have been underserved and forgotten for far too long.

The Trust has passionately devoted itself to diverse focus areas encompassing education, healthcare, disaster relief, women and children in distress, training and rehabilitation and livelihood. We diligently seek opportunities for making effective contributions for meaningful outcomes and impact by fostering collaboration with reputed NGOs and organizations with shared vision and common objectives.

The North East Region of India, with its breathtaking natural beauty, rich social and cultural diversity, abundant natural resources, but stark under development, deserves much more attention and support. There is a palpable and visible dearth of investment for upliftment of marginalized sections of the social sector in this region which the Trust wishes to bring to the awareness of mainstream philanthropy and seek philanthropic engagement to help to bridge this gap.

At the heart of our endeavor lies the process of identifying, connecting with, and offering financial support and guidance to beneficiaries through thoughtfully planned, carefully executed and monitored projects and schemes. We collaborate with partner NGOs to execute schemes on a sustainable basis.

In this Annual Report, we present the stories of transformation and resilience that inspire us every day. With your continued support, we are confident that our endeavours will continue to forge a path of hope and optimism to illuminate the futures of those we serve.

The Trust has donated  $$\mathbb{P}$$  76,21,508.00 during the Financial Year 2022 - 23 against a budget of  $$\mathbb{P}$$  100Lakhs. Proper procedure with necessary compliance has been observed in making the donations, monitoring expenditures and measuring outcomes. The Trust is taking all steps required as per statutory obligations and Income Tax regulations.

#### COMPLETED PROJECTS

#### GHAROA:

Gharoa is a non-profit organization based in Lumding, Assam, established in 1991. It works on community health, serving as an Eco Club of MoEF and focusing on immunization, maternal and child health along with being a defender of Women's Rights, combating domestic violence, promoting sustainable agriculture, water harvesting, and addresses issues like malnutrition, HIV/AIDS and livelihood among tribal communities affected by natural disasters in Dima Hasao. The Trust began its collaboration with Gharoa in 2022 by extending financial support for relief work in areas which were ravaged by flood by the early monsoon rains of April 2022.

## CACHAR CANCER CARE HOSPITAL & RESEARCH CENTRE:

The Trust has been working in collaboration with Dr. R. Ravi Kannan and the Cachar Cancer Care Hospital and Research Centre, Silchar, supporting their philanthropic initiatives in the health care services in Barak Valley, Assam, for the economically impoverished cancer patients who otherwise would not have received any treatment. This year the Trust helped to procure of a utility motor vehicle and some necessary medical equipment. Dr. R. Ravi Kannan was honoured with the award of the Padma Shri in 2022.



#### ATMA NIRBHAR - EK CHALLENGE (ANEC):

ANEC is a Presidents National award-winning NGO providing economic rehabilitation to very poor mentally and physically challenged adults. ANEC gives opportunities to such individuals to work with dignity and earn a living by running a facility for blending and packaging tea, spices and grocery items for various retailers. The SCKC Trust has been associated with ANEC since 2021 by supporting the operational expenses of the organization.



#### PRAMOD TALUKDAR MEMORIAL OLD AGE HOME — A UNIT OF MONALISHA SOCIETY:

Under its rehabilitation initiative the Trust has been supporting the Pramod Talukdar Memorial Old Age Home run by the Monalisha Society for a few years now. The newest home for the elderly people in LNB Path, Hatigaon required certain infrastructural support which was provided.

We appreciate Monalisha Society and the volunteers for providing tirelessly for the inmates of the Old Age Home.



## INDIAN COUNCIL FOR CHILD WELFARE — SISHU GREH:

The Indian Council for Child Welfare (ICCW), Assam State Branch, is a national organization dedicated to addressing the challenges faced by abandoned, vulnerable and marginalized children in the state. The Trust has been associated with the ICCW since 2018, but has been particularly involved with the specialized facility unit "Shishu-Greh" where infants of age 0-6 months and older are taken care of. The Trust has been providing the full requirement of baby milk food (lactogen etc.) for the infants in the facility since March 2021. The Trust continues to provide its support to ICCW-Sishu Greh and applauds their devotion and dedication.



#### NORTH EAST EDUCATIONAL TRUST (NEET):

NEET along with their other activities in the field of education, operates a Community Library cum Learning Centre. Through this initiative NEET aims to provide academic support through a positive learning and motivating environment to children attending Government schools from economically weak sections who lack the required support at home. The children who benefit from these overcome disabling circumstances and tend to do well without dropping out of school. The library aims to create a vibrant learning space and promote a culture of learning and exploration among children from poor marginalized communities which is accessible only to children from well-to-do backgrounds. The Trust has collaborated with the NEET by supporting the operating expenses of the Community Library.



#### **WORLD VISION INDIA:**

World Vision India is a child-focused humanitarian organization serving vulnerable children and their families for over 70 tears by working in areas like child health, education, livelihood, gender empowerment, etc. The Trust has worked with WVI for about three (3) years aiming to impact the lives of well-deserving academically brilliant students to overcome their deprivations to create a better future for themselves and their communities. The financial assistance rendered by the Trust has encouraged the students to materialize their dreams and achieve their goals. Apart from covering the entire academic expenses, the Trust also provided a personalised laptop to the beneficiary students. But due to WVI's discontinuation of its operations in Guwahati, the Trust had to conclude its collaboration with WVI. However, the Trust continues to support the existing student pursuing BE at NIT, Surathkal, Karnataka.

#### MORAN BLIND SCHOOL - JAAB:

The Moran Blind School established in 1976 under the name "Janamangal Adarsha Andha Bidyalaya" was founded by Bruno SN Banerjee, who also donated the land to develop the infrastructure of the school. His son, a veteran actor and Padma Bhushan Awardee Mr. Victor Banerjee is the President of the Organization. This residential school provides free education to about 65 visually impaired students from the neighbouring villages and tea gardens belonging to economically challenged families. The Trust has been supporting the operational expenses of the Moran Blind School - JAAB since 2019.



#### ONGOING PROJECTS

#### ASHA DARSHAN:

The Trust has collaborated with Asha Darshan to support their philanthropic activities in the field of education. After a successful completion of the construction of the Satya Narayanapur M.E. School in 2021 - 22 the Trust decided to construct another school in the Nagapur area of Tamulpur, Chirang District where there are no Government Schools. The school is located about 2 km away from the Indo-Bhutan international border and is separated by a river from the mainland which gets heavily flooded during the monsoons. The children of neighbouring eight villages were deprived of acquiring formal education. Asha Darshan has been operating a school in the area with the bare minimum facilities available with the limited resources. The village leaders assured that the residents will take responsibility of maintaining and taking care of the school if a permanent pucca school building is constructed in the same compound. Currently construction is nearing completion consisting of 15 classrooms, 1 Teachers' common room, 1 computer lab room, 1 kitchen and dining Hall. The construction began in December 2022 and is expected to be over by October 2023.






#### ADHYAYA:

Adhyaya is a charitable trust working diligently towards empowering the youth from economically challenging background through education. The Trust has been rendering financial assistance to most deserving academically brilliant students identified by Adhyaya through their mentorship programs. Since 2021, the Trust has been supporting the students under the Luit Scholar program through full scholarships for those pursuing higher studies who otherwise would have had to abandon their dreams without any means to achieve their potential. The Trust has selected five (5) students suggested by Adhyaya this year after their in-person interviews. Four (4) Luit scholars and fellows selected in previous years continue to receive full assistance for their academic pursuits.

#### RASHTRIYA GRAMIN VIKASH NIDHI (RGVN):

The Trust upon receiving the second collaborative project under the "Grasslooms" scheme of RGVN to develop an Eri cluster in the Mayong area of Morigaon district, decided to get on board after a detailed field survey regarding the credibility of the proposed project. This particular project has been funded under the livelihood support programme of the Trust. It will benefit 50 women "Eri" rearers, spinners, dyers and weavers. It is not only a livelihood support programme, but also an attempt to revive and promote the scale of rearing of Eri silk worms, spinning the Eri yarn, use of natural dyes and weaving various garments. Under this project RGVN is providing trainings in different phases to the beneficiaries on Eri Silk worm rearing, Yarn spinning, Natural dying of the Eri yarn and weaving. RGVN also provides a platform to the weavers in marketing their creation which has highly developed an entrepreneurial character among the women involved with them.





#### CENTRE FOR DEVELOPMENT INITIATIVE

#### (CDI):

The Centre for Development Initiative, a social wing of the Missionary Sisters of Mary Help of Christians (MSMHC) has collaborated with the Trust on various programmes since 2019. From 2021-2022 Financial Year, the Trust has supported CDI in their Rehabilitation and Livelihood Training for young girls rescued from trafficking. This is a residential program conducted for 3 months at the Ferrando Vikas Kendra, Bullarpar, Kamrup (Near LGBI Airport). For this calendar year CDI has planned to train at least 4 batch of girls on Cutting-Tailoring and Housekeeping. Along with the formal training, the girls are engaged in various recreational activities and are also given self-defence classes by trained professionals. Post the training CDI also helps in employing the trainees in various reliable organizations. The current project began in January 2023 with the First batch and is supposed to be completed in December 2023 with the Fourth batch.

The Trust applauds CDI for their untiring service towards the rehabilitation of women and girls who have suffered terribly.



#### FLOOD SHELTER - HOIBORGAON, MORIGAON:

The Morigaon district is bounded by the mighty Brahmaputra River, which flows along with the northern boundary of the district. The topography of Morigaon causes flooding in the district wreaking havoc beginning from the monsoon season lasting for several months in certain areas. The Hoiborgaon Char, an island in the Brahmaputra River is among the most remote areas which gets heavily flooded and remains disconnected from the mainland as the water level of the Brahmaputra rises, disrupting the ferry services, the only mode of communication between the island and the mainland.

The District Commissioner approached the Trust to construct a permanent flood shelter on a raised platform which can be used by the residents during heavy flooding. The shelter is expected to provide great relief to the residents of the area and help them save their harvest, valuables and their cattle. Considering the dire necessity of a permanent shelter The Trust decided to construct the shelter by commissioning a contractor recommended by the District Commissioner himself. The construction began in the month of February and is expected to complete by the month of September 2023. Considering the difficulty in transportation of construction materials and the disabling conditions in the island area the construction is taking comparatively longer time to complete.





# EDUCATION FELLOWSHIP FOR INDEPENDENT STUDENTS

#### KAUSHIK SHARMA:

Kaushik is pursuing Diploma in Plastic Technology (DPT), a 6-semester diploma course to be completed within 3-years, from the Central Institute of Plastics & Engineering Technology (CIPET), Changsari, Guwahati. Kaushik's father was a vehicle operator at a reputed organization but lost his job due to the outbreak of Covid-19 pandemic and failed to have a regular earning, which affected Kaushik's education. The Trust was approached to support the remaining 2-years (4-semesters) of his Diploma course in CIPET, to which the Trust agreed to provide him the needful financial assistance as his case was verified by one of the Trustees.

#### **BIKASH DAS:**

Bikash is a student of Jatiya Bidyalaya, Noonmati. He passed his HSLC Examination in 2022 and secured 86.5% while scoring 100% in Mathematics. Bikash aspires to pursue Medical Science and be a doctor. But considering his father's limited earning from being a vehicle operator, the dream to study his choice of subjects seemed unaffordable. The Trust when brought to light about the case of this student decided to provide him the necessary academic mentorship and fully support his academic expenses from Class XI onwards. Bikash is currently a student of the Science stream, Class XI in Jatiya Bidyalaya, Noonmati, Guwahati.
