

# **SECRETARY'S REPORT:**

We are pleased to present the Annual Report of the Sarat Chandra Kagti Charitable Trust for the year 2023-2024.

Since our inception in 2017, our guiding philosophy has been to effectively channelize financial assistance and other resources to address pressing socio-economic issues at the grassroots level. Our journey began with a singular purpose – to make a meaningful difference in the lives of those who have been underserved and neglected for too long. The Trust concentrates its focus on the education, healthcare, disaster relief, women and

children in distress, training and rehabilitation and livelihood sectors. We seek opportunities for making effective contributions for delivering meaningful outcomes and impact by fostering collaborations with reputed NGOs and organizations with shared vision and common objectives.

The North East region of India, with its breathtaking natural beauty, rich social and cultural diversity, abundant natural resources, but stark under development, deserves much more attention and support. There is a palpable and visible dearth of investment for upliftment of marginalized sections of the populace in this region who languish at the bottom of the pyramid. The Trust wishes to draw the awareness of mainstream philanthropy and seek philanthropic engagement to help to address the burning issues of neglect in these sectors.

At the heart of our endeavor lies the process of identifying, connecting with, and offering financial support and guidance to beneficiaries through thoughtfully conceived, carefully executed and monitored projects and schemes on a sustainable basis.

# **ABOUT THE TRUST:**

The Sarat Chandra Kagti Charitable Trust is a registered non-profit organization dedicated to uplifting and supporting the most vulnerable segments of the society, especially those at the base of the socio-economic pyramid. Since its inception in 2017, the Trust has been committed to bringing about tangible, visible and measurable improvements and benefits in the lives of those most needy of support and assistance across the state of Assam and parts of the Northeastern region of India.

# **OBJECTIVE OF THE TRUST:**

The Trust was established to support and uplift the most vulnerable and marginalized individuals and communities, regardless of their religion, caste, creed or background. Its mission includes financially supporting the implementation of projects, schemes, programs and measures designed to aid the deprived, poor and neglected with the aim of improving their lives by providing them with opportunities for a more fulfilling and better future. The Trust's activities are specifically targeted towards individuals and communities at the bottom of the socio-economic pyramid, focusing broadly on areas of Education, Healthcare, Livelihood, Relief and Rehabilitation. We focus on the needs and necessities of those impacted by deprivations, marginalization, abuse, neglect, calamities and conflicts. The Trust strives to identify and address these issues at locales which often remain unnoticed by larger philanthropic organizations.

# EDUCATION

The Trust has been working towards making meaningful contributions in the education sector. This is being done through (I) awarding scholarships and comprehensive financial support to very deserving students identified and mentored by reputed NGOs working in the sector and (II) developing infrastructure for schools located in remote and underserved areas. Until recently the Trust has collaborated with World Vision India by financially supporting a number of students recommended by them for higher studies in reputed government institutions within the state and also in other national institutions. Of these students, Monu Kumar is in his eighth and last semester of B.Tech course in Civil Engineering from NIT Surathkal, Karnataka. After completing Engineering Monu aspires to prepare for UPSC examination, in which the Trust will support him by covering all the required expenses for his preparation including coaching and other academic materials.

## ADHYAYA, GUWAHATI:

Adhyaya, based in Guwahati is a charitable trust working at the grassroots to empower meritorious youth from economically challenged backgrounds through assured financial support that enables them to secure admissions to reputed institutions with a promise of their future success in chosen career paths. The Trust has been providing scholarships to students under the Luit Scholar program of Adhyaya to those students pursuing higher studies who otherwise would have had to abandon their dreams without any means to achieve their potential. A total number of 13 students mentored by Adhyaya have been supported by SCKCT till date with scholarships that cover all academic costs.

# **INDIVIDUAL SCHOLARSHIPS:**

Based on strong references/recommendations the Trust has extended full-scholarships to meritorious students from underprivileged and disadvantaged backgrounds.

#### **KAUSHIK SHARMA:**

Kaushik is pursuing Diploma in Plastic Technology (DPT) from the Central Institute of Plastics & Engineering Technology (CIPET), Changsari, Guwahati and is in the last semester of his academic course.Kaushik was selected to pursue his internship program at the Supreme Industries Ltd. Manufacturing Unit, Kamalpur, Assam.

#### **BIKASH DAS:**

Bikash is a student of Assam Jatiya Bidyalay, Noonmati, in Class 12 and has appeared in the final board examination. He passed his HSLC Examination in 2022 and secured 86.5% while scoring 100% in Mathematics. Bikash aspires to pursue Medical Science and be a doctor. But considering his father's limited earning from being a vehicle driver, the dream to study medicine seemed impossible. The Trust decided to provide him academic mentorship with a new Laptop and full-financial support with academic expenses from Class XI onwards.

# NORTH EAST EDUCATIONAL TRUST (NEET), GUWAHATI:

NEET designs and offers classroom programs that focus on bridging the deficit in academic development that is starkly noticed in children in primary government schools that lead to high percentage of school drop-outs. NEET operates a community library cum learning centre through which they aim to provide academic support by providing a positive learning environment for the children belonging to economically impoverished families to help them succeed in satisfactorily completing their school education. Through this library NEET creates a vibrant learning space promoting a culture of learning and exploration among the target beneficiary children. The Annual Status of Education Report (ASER) data clearly points out the gross lacunae at the primary level and testifies to the extremely poor standards of education in the country.

According to ASER 2022 data, 71.9% children enrolled in govt. schools in 2022 compared to 71.7% in 2018, based on Std. III Learning Levels, 19.9% in 2018 and 17.9% children could read Std. II level text and 29.7% in 2018 and 24.4% in 2022 could do at least subtraction. For nearly two decades, ASER Reports have consistently pointed towards the fact that many children in elementary schools need urgent support for acquiring foundational skill like reading and basic arithmetic.



## ASHA DARSHAN, TAMULPUR, BAKSA:

A Tamulpur, Baksa district based charitable trust working in the education sector to develop the condition of education in the remote and underdeveloped areas near the Indo-Bhutan border. The Trust has collaborated with Asha Darshan to support their activities by financing construction of school buildings and infrastructure. In 2022, the school building at Satyanarayanpur M.E. School was completed. Gauging the very positive impact the new building had on students, parents, teachers and the community, the Trust decided to embark on a second collaborative project and began the construction of the building of Asha Darshan's Nagapur School in Tamulpur, Chirang District where there are no Government Schools beyond class five. The Indo-Bhutan International Border is about 2 kilometers away from the school which is approachable across a river which gets heavily flooded during the monsoons and disrupts all road communication in the area. Asha Darshan has been managing this school with very poor infrastructure that has severely affected the education of the children from eight neighboring villages. The construction of Nagapur School consistingof 12 classrooms, 1 Teachers' common room, 1 computer lab room, 1 kitchen and dining hall, separate toilets for boys and girls with running water was completed in the month of February 2024.

# KUMONGGRIKANI ST. JOSEPH SCHOOL, CHIRINGGRO, EAST GARO HILLS, **MEGHALAYA:**

The school is being run by the Purvanchal Pragati Samaj in collaboration with the Family Groups in the Chiringgro village located in a difficult terrain with poor access. The temporary school structure was established by the "Kumonggrikani St. Joseph School" on 2nd February 2020 with an enrollment of 76 students for Nursery class. With 303 total students from class Nursery to class 2, with 5 teachers the school is run by the Family Groups. The Trust decided to accept the proposal to support the infrastructure development of the school building by financing a semipermanent structure post a visit by the SCKCT Team which considered the request to be very genuine. Post construction, the impact on all the stakeholders of the school has been very visible and heartening. The Trust has also agreed to finance the leveling of a playground for sports and other activities.

## ST. MARY'S ENGLISH SCHOOL, DHOLMARA, BTR, KOKRAJHAR:

The Trust accepted a proposal submitted by Mr. Ronal Ekka, a committed social worker and founder of the St. Mary's English School. A partially built structure stood on a plot of land donated by Mr. Ekka. Preliminary visits revealed that despite the poor temporary school-shed the students were highly motivated by a very dedicated group of teachers. The parents and community in general played a hands-on role in the functioning of the school. The Trust decided to directly execute the construction of the school building comprising of 8 classrooms, library, computer room, teachers' staffroom and principal's office and a separate toilet unit comprising 4 toilets, 2 each for boys and girls. The roof-truss was made of iron and covered with high quality Dynaroof roofing sheets for longer durability. The school is equipped with 24-hours supply of water and electricity. The new school building was inaugurated on 11th May 2024.

# **HEALTHCARE:**

### CACHAR CANCER HOSPITAL AND RESEARCH CENTRE, SILCHAR, ASSAM (CCHRC):

The CCHRC is a non-profit organization that provides cancer care to very poor patients from remote regions of Assam's southern border districts, neighboring states like Meghalaya, Manipur and Tripura. One of its kind, the hospital caters to more than 24,000 patients annually, most of whom are treated free of cost or at highly subsidized charges. The SCKC Trust has been extending financial assistance to CCHRC for treatment of patients belonging to economically downtrodden sections of the society who otherwise would have been deprived of the required medical assistance.

# LIVELIHOOD:

## ATMA NIRBHAR – EK CHALLENGE (ANEC):

ANEC has won National recognition and awards for its initiative to provide economic rehabilitation to very poor physically and mentally challenged adults. The organization offers opportunities to such individuals to work with dignity and earn a living. ANEC operates a facility for blending and packaging of quality teas, spices, groceries, etc. by executing work orders from grocery chains. ANEC also sells its own premium brand Navjeevan. The Trust provides financial assistance to supplement the wage and salary expenses of ANEC which has to compete in the market with the disadvantage of low productivity. By empowering the poor and differentlyabled, ANEC is a pioneering NGO helping to create a more inclusive world. Their efforts serve as an inspiration to others to promote equality and provide opportunities to the marginalized.

### **CENTRE FOR DEVELOPMENT INITIATIVE, (CDI):**

CDI is a social wing of the Missionary Sisters of Mary Help of Christians (MSMHC) with a mission to uplift the most vulnerable, particularly women and children. CDI conducts various training and skilling programs that are designed to motivate and empower the beneficiaries to take control of their lives and affairs as productive individuals thereby enabling them to live more meaningful and purposeful lives. The programs encompass various skills such as tailoring, housekeeping, elderly and child care, domestic work, cooking, and kitchen-related tasks. Since December 2019, the SCKC Trust has partnered with CDI on collaborative projects, training programs for rescued girls and young women who have been victims of trafficking, domestic violence, sexual abuse and forced labor. These young women almost entirely belong to the poorest, neglected and disadvantaged backgrounds.

# **RELIEF:**

## **GHAROA, LUMDING:**

Gharoa mainly works in Southern districts of Assam and has been actively involved in various areas of social and environmental development. Gharoa remains in the forefront during natural disasters and floods and has earned recognition for its organizational abilities to channelize relief and rehabilitation materials including food, medicines, temporary shelter etc. to most needy, disadvantagedand deprived communities which face the brunt of all calamities. The Trust extends financial assistance to Gharoa whenever required to help them in carrying out their relief operations.


### MATAI SOCIETY, BISHNUPUR, MANIPUR:

Matai Society is a youth, women, queer and trans-led registered society based in Moirang, Bishupur district, Manipur. It has been providing relief work for the people displaced and affected by conflict since violence broke out in Imphal and its adjacent areas in May 2023. Along with other relief materials they are engaged in trauma response activities amongst youth and children affected by conflict through recreational, psycho-social, nutritional and educational support to people living in the relief camps. The Trust was approached for assistance to purchase a projector, white screen and speakers tobe used for educational programs for the children and also recreational and motivational content for addressing and healing the psychological and mental health issues of the inmates as a result of their traumatic experiences.

#### **CATHOLIC EDUCATION SOCIETY MANIPUR, IMPHAL, MANIPUR(CESM):**

CESM is a registered NGO under the Manipur Registration Act, 1989, and 80G certified. Dedicated to educational, social, and charitable activities, CESM operates numerous schools and hostels across Manipur, offering affordable education and boarding regardless of caste, creed, religion, or gender. The Society conducts various activities to promote the wellbeing and harmonious coexistence of communities. The SCKC Trust was approached with a proposal for financial support for academic and boarding expenses for 50 children during the on-going conflict in Manipur, by moving them out from the camps and admitting them to CESM Schools with boarding facility. This support enabled the middle school children to continue their education without break.

# **REHABILITATION:**

## SANTANEER:

Santaneer is a home providing shelter and care to elderly men and women living without family care and support. They focus on providing holistic care and well-being for all their inmates in a pristine environment away from the chaos of the city. The team of Santaneer caters to the inmates' emotional, mental and spiritual well-being through counseling and other relevant activities. Basic medical treatment is made available at the facility and for other medical necessities the inmates are taken to nearby medical facilities as and when required.

#### **INDIAN COUNCIL FOR CHILD WELFARE (ICCW):**

ICCW, Assam State Branch, is a national organization dedicated to addressing the challenges faced by abandoned infants, vulnerable and neglected children in the state. The SCKC Trust donates the entire requirement for baby food and milk for all infants and children aged 0 to 6 months and older who are housed and cared for at "Shishu Greh" home for children. The SCKC Trust has been associated with ICCW since the year 2018.

### **SNEHALAYA:**

Snehalaya is a 'Salesians of Don Bosco' initiative to provide love, care and protection for children and build their lives through various supportive programs and services. It provides a home for street children in distress and counsels and educates them to become responsible future citizens. Snehalaya was founded by Father Lukose Cheruvalel in Guwahati and has been operational since January 2001. The Trust has extended financial assistance to Snehalaya in the past and also in this Financial Year for meeting the academic and residential expenditure of the children currently residing in their facilities.

### BHABADA DEVI MEMORIAL PHILANTROPHIC TRUST (BDMPT) - SENEH, GUWAHATI:

BDMPT is a public charitable trust which has established and operates a special facility for rehabilitating very vulnerable elderly women who do not have any home or family. The home named "Seneh" which stands for affection functions as the final destination for women who are abandoned. Seneh responds to information from public sources and police to rescue women (including from the streets), many of whom suffer from psychological and mental issues, and give them shelter and a dignified and comfortable life with high standards of hygiene and nourishment. Seneh takes care of all the health care requirements of its inmates. It works on an admirable model where almost all the upkeep and cooking works are looked after by the inmates themselves. The SCKCT donated a multipurpose vehicle to Seneh which they requested for carrying out transportation chores and taking the inmates to hospitals for checkups etc.

#### **PERMANENT FLOOD SHELTER - BORALIMARI, HOIBORGAON, MORIGAON:**

The Morigaon district is bounded by the mighty Brahmaputra River, which flows along the northern boundary of the district. The topography of Morigaon causes flooding in the district wreaking havoc beginning from the monsoon season lasting for several months in certain areas. The Hoiborgaon Char, an island in the Brahmaputra River is among the most remote areas which get heavily flooded and remains disconnected from the mainland as the water level of the Brahmaputra rises, disrupting the ferry services, the only mode of communication between the island and the mainland.

With the support of the District Commissioner the Trust constructed a permanent flood shelter on a raised platform on the island char, which has been planned to provide shelter for the aged, ailing, pregnant and young women with infants from the local populace. Cattle can also take shelter during heavy flooding. The construction was completed in September 2023 with significant cost overruns due to the very difficult and expensive process of transportation of materials to the site. It is very satisfying and heartwarming that the shelter came into full use during the floods last year and also the recent floods this season. It is noteworthy that the construction of the shelter has been appreciated as a replicable model at the highest level of government.

# **PERMANENT FLOOD SHELTER - KATHONI, LAHORIGHAT, MORIGAON:**

With the successful launch of the first shelter at Boralimari and greatly encouraged by the beneficial impact on the flood ravaged populace, the Trust was encouraged to take up construction of a similar but larger permanent shelter at Kathoni as suggested by the District Commissioner. The construction of the second shelter began in January 2024. The constructed area is separated from the severely flood affected areas by an embankment constructed to block the rising water of the Brahmaputra River during the flood season. The ongoing construction is expected to be completed and inaugurated during September 2024.
